MISHAP REPORTING INSTRUCTIONS

All squadrons should fill in their local information and post this on their safety board, in all aircraft binders and all CAP vehicles.

In the event of a mishap:

1. Notify your Squadron Commander (or Activity Director) and/or Squadron (Activity) Safety Officer.
2. The Commander (or designee) shall notify 1 person in the above staff list starting at the top, working down until making contact.
3. That staff person shall then make all other required notifications.
4. In the event of an accident (see CAPR 62-2) the NOC must be notified immediately (wing staff will guide you on this requirement).
5. In the event of a death or bodily injury from an accident, do not fill out the accounts portion of the CAP Form 78 without NHQ legal staff guidance.
6. An online CAP Form 78 is required for all mishaps within 48 hours. The wing safety officer will guide you through this process.
7. In the event you are unable to reach anyone in the above list, continue with the list below until making contact.
